

Privacy policy

This privacy Policy for personal information (hereinafter referred to as the Policy) applies to all information that pbsspb.com they can get information about the user while they are using the site. The user's consent to the provision of personal information given by them in accordance with this Policy in the framework of relations with one of the parties included, applies to all persons. Usage pbsspb.com this means that the user unconditionally agrees to this Policy and the terms of processing of their personal information specified in it; in case of disagreement with these terms, the user must refrain from using the Services.

1. Personal information of users that pbsspb.com receives and processes

1.1. Within the framework of this Policy, “personal user information” means:

1.1.1. Personal information that the user provides about himself when filling out feedback forms, including personal data of the user. Information required for the provision of Services (provision of services) is marked in a special way.

The user at his discretion provides other information.

1.1.2 Data that is automatically transferred in the process of their use using the software installed on the user's device, including the IP address, information from the cookie, information about the user's browser (or other program that accesses the Services), access time, address of the requested page.

1.2. This Policy applies only to pbsspb.com. pbsspb.com does not control and is not responsible for third-party sites to which the user can click on the links available on the pbsspb.com website, including in search results. On such sites, the user may collect or request other personal information, and other actions may be performed.

1.3. pbsspb.com generally does not verify the accuracy of personal information provided by users, and does not exercise control over their legal capacity. However, pbsspb.com assumes that the user provides reliable and sufficient personal information on the issues proposed in the registration form, and maintains this information up to date.

2. Purposes of collecting and processing users ' personal information

2.1. pbsspb.com collects and stores only those personal data that are necessary for the provision and provision of services (execution of agreements and contracts with the user).

2.2. The user's personal information pbsspb.com can be used for the following purposes:

2.2.1. Party identification within agreements and contracts with pbsspb.com 2.2.2.

Providing personalized services to the user;

2.2.3. Communication with the user, including sending notifications, requests and information related to the use of the Services, provision of services, as well as processing requests and requests from the user;

2.2.4. Improving the quality, usability, and development of services;

2.2.5. The targeting of advertising materials;

2.2.6. Carrying out statistical and other researches based on depersonalized data.

3. Terms of processing of the user's personal information and its transfer to third parties

3.1. pbsspb.com stores users ' personal information in accordance with the internal regulations of specific services.

3.2. the user's personal information is kept confidential, except for cases when the user voluntarily provides information about himself for General access to an unlimited number of persons. When using certain Services, the user agrees that a certain part of their personal information becomes publicly available.

3.3. pbsspb.com the right to transfer the user's personal information to third parties in the following cases:

3.3.1. The user expressed his consent to such actions;

3.3.2. the Transfer is necessary as part of the user's use of a particular Service or to provide a service to the user;

3.3.3. the Transfer is provided for by Russian or other applicable legislation in accordance with the procedure established by law;

3.3.4. such transfer takes place as part of a sale or other transfer of the business (in whole or in part), and the acquirer assumes all obligations to comply with the terms of this Policy in relation to the personal information received by them;

3.3.5. in order to ensure the possibility of protecting rights and legitimate interests pbsspb.com or third parties in cases where the user violates the user agreement of the services pbsspb.com.

3.4. when processing personal data of users pbsspb.com it is governed by the Federal law of the Russian Federation "on personal data".

4. Change of personal information by the user

4.1. the User may at any time change (update, Supplement) the personal information provided by them or part of it, as well as the parameters of its confidentiality.

5. Measures used to protect users ' personal information pbsspb.com

5.1 pbsspb.com takes necessary and sufficient organizational and technical measures to protect the user's personal information from unauthorized or accidental access, destruction, modification, blocking, copying, distribution, as well as from other illegal actions with it by third parties.

6. Changing the privacy Policy. Applicable law

6.1. pbsspb.com has the right to make changes to this privacy Policy. When making changes in the current version, the date of the last update is indicated. The new version of the Policy takes effect from the moment it is posted, unless otherwise provided for in the new version of the Policy.

6.2. this Policy And the relationship between the user and pbsspb.com the law of the Russian Federation shall apply to any disputes arising in connection with the application of the privacy Policy
